# **Privacy Policy**

#### Introduction

Greetings and thank you for using <a href="www.certifiedskilledworkers.global">www.certifiedskilledworkers.global</a> (the "Website") as your portal for employment services. Our Website is operated by HUMAN CAPITAL PROJECT MANAGEMENT (the "Company"). #### **Your Information**

The Company will collect from you information that will put you in a good light in front of your potential Employer. This information can be personal and/or professional information and General Information.

Personal / Professional / Employer Information / Certified Skilled Worker:

The data you provide us like data keyed into the Website, emails sent to the Company will be stored and processes to help you to increase your chance of securing your next job. Information collected will not point out individual users.
